### **Overview**

The FSM Government is seeking to hire a Consultant/Professional to perform the assignment/services described below.

The services include assisting the FSM Government in developing a plan (1 set document) to achieve establishment of an ICT office/unit that will be responsible for the administration and management of the FSM Government ICT Network. The FSM Department of Transportation, Communications and Infrastructure (FSM TC&I) will be the lead agency during this project.
